The unbroken area is situated in northern part of the province of Western Finland, in the municipalities of Kaustinen and Veteli, 12 km southeast of Kaustinen village. The municipalities (860 sq.km of land) have ca. 8 200 residents.

10. Overview:

Pilvineva Mire is an unusually extensive, unbroken and diverse mire area in Middle Ostrobothnia with a valuable wetland bird fauna.

1) A representative example of natural and near-natural wetland types (peatlands) in the EU Boreal region, including 2 priority natural wetland habitat types of the European Habitat Directive (aapa mires, active raised bogs).

2) About 19 species of the EU Birds Directive Annex I breed in the area, of which the most common (tens of pairs) are Black Grouse (*Tetrao tetrix*), Golden Plover (*Pluvialis apricaria*), Ruff (*Philomachus pugnax*) and Wood Sandpiper (*Tringa glareola*) as well as Merlin (*Falco columbarius*). Scarce species include e.g. Whooper Swan (*Cygnus cygnus*), Hen Harrier (*Circus cyaneus*), Osprey (*Pandion haliaetus*), Crane (*Grus grus*), Red-necked Phalarope (*Phalaropus lobatus*) and Short-eared Owl (*Asio flammeus*).

Nationally threatened bird species are Black-tailed Godwit (*Limosa limosa*) (EN in Finnish Red List), Merlin (*Falco columbarius*) (VU also Bird directive) and Black-headed Gull (*Larus ridibundus*) (VU).

4) Pilvineva is also an important staging area for Bean Goose (*Anser fabalis*) and Crane (*Grus grus*) in migration periods.

Geology: Geochemically included in Svecokarelian schist belt. Bedrock is composed of granite.

Origins: Natural.

Hydrology: Raised bogs dependent on rain water and aapa mires on surface waters.

Soil type: Peat with smaller areas of glacial ground moraine.

Water quality: Mire waters dystrophic.

Depth of water: Shallow. Water-level high in spring because of melting snow.

Climate: Duration of growing season ca. 155 days, mean annual temperature ca. +3 °C, mean annual rainfall ca. 550 mm. Ice- and snow-covered normally from early December to early April. Middle boreal forest vegetation zone.

15. Physical features of the catchment area:

The climate and general geological features are much the same in the catchment areas as in the Ramsar sites. Look partly chapter 14.

Virgin mires play an important role in maintenance of water quality.

18. General ecological features:

The site represents the Mire vegetation regions of Eccentric bogs and *Sphagnum fuscum* bogs and of Southern aapa mires. The area includes ca. 3 100 ha of mires and ca. 40 ha of water. Pilvineva is formed by an extensive and constant mire area dominated by large eccentric raised bogs. Hollows and ponds are common middle parts. Mire types are barren and northern parts consist of minerotrophic poor fens of aapa mire type. Pine (*Pinus sylvestris*) bogs and Spruce (*Picea abies*) mires occur on the edges.

Threatened birds include Black-tailed Godwit (*Limosa limosa*) (EN in Finnish Red List), Merlin (*Falco columbarius*) (VU) and Black-headed Gull (*Larus ridibundus*) (VU). Ca. 19 species of the EU Birds Directive Annex I breed in the area, of which the most common (tens of pairs) are Black Grouse (*Tetrao tetrix*), Golden Plover (*Pluvialis apricaria*), Ruff (*Philomachus pugnax*) and Wood Sandpiper (*Tringa glareola*). Scarce species include e.g. Whooper Swan (*Cygnus cygnus*), Hen Harrier (*Circus cyaneus*), Osprey (*Pandion haliaetus*), Crane (*Grus grus*), Red-necked Phalarope (*Phalaropus lobatus*) and Short-eared Owl (*Asio flammeus*). Pilvineva is also an important staging area for Bean Goose (*Anser fabalis*) and Crane in migration periods.

State-owned for the major part (80 %).

Private-owned.

None significant.

(b) in the surroundings/catchment:

Forestry is carried out in the surroundings.

24. Factors (past, present or potential) adversely affecting the site's ecological character, including changes in land (including water) use and development projects:

Drainage has been carried out in small areas on the edges. Forestry in the surroundings affect negatively on the site.

25. Conservation measures taken:

List national category and legal status of protected areas, including boundary relationships with the Ramsar site; management practices; whether an officially approved management plan exists and whether it is being implemented.

The site is included in the Natura 2000 Network, designated both as SPA and SCI, and in the Mire Conservation Programme. Pilvineva is designated as the UNESCO World Heritage site Pilvineva Mire Protection Area (3 094 ha) was established in 1988 and enlarged in 1992. Forestry, ditching, extraction of earth material and damaging of soil or bedrock are prohibited in the Mire Protection Area. Also construction of new buildings and roads is prohibited in general.

Conservation of the Natura 2000 site outside the already protected areas will be carried out under the Nature Conservation Act.
